JUSTICE PROGRAMME - JUST-JCOO-AG-2020

The aim is to promote judicial cooperation in civil, in criminal and in commercial matters (priorities 1,2 and 3) to contribute to the effective and coherent application and enforcement of EU instruments. Other aim (priority 4) is to support to Member States for their connection to the ECRIS-TCN system. Whereas several measures and initiatives are listed, it is not requested to include all of them in a single project. Projects with a strong focus are very much valued.

For priorities 1 and 2 the applications involve at least 2 organisations from at least 2 eligible countries. For priorities 3 and 4 the applications involve a single applicant or a partnership.
