CALL FOR EXPERTS - ONE HEALTH HIGH-LEVEL EXPERT PANEL - OHHLEP

La Food and Agriculture Organisation (FAO), il World Organisation for Animal Health (OIE), lo United Nations Environment Programme ("UNEP") e il World Health Organization (WHO) hanno aperto una call per selezionare esperti da inserire nell'One Health High Level Expert Panel (OHHLEP).

In considerazione della complessità della tematica One Health, sono richiesti esperti sulle seguenti aree:

- emerging infectious diseases and zoonoses
- viral diversity, surveillance and risk assessment for emerging pandemic threats
- infectious disease epidemiology, prevention and control
- biodiversity, wildlife and ecosystems health
- health systems policy and practice and pandemic preparedness
- food systems and their interlinkages with health
- social, economic and behavioural sciences relating to One Health

- climate and environment.

The Interreg Europe monitoring committee approved the terms of reference of a call for additional activities restricted only to the 258 Interreg Europe projects.

This exceptional measure offers the possibility for approved projects:

- to further exchange experiences on the way the crisis impacts the issue they address and on possible measures to face and recover from the crisis,
- to further improve their regional development policies to better face and recover from this unprecedented situation.

Human Brain Project

HUMAN BRAIN PROJECT AND EBRAINS RESEARCH INFRASTRUCTURE - Call for Expression of Interest on impact of Covid-19 on brain and mental health

Scientists and physicians have today come to recognize the important impact of the COVID-19 pandemic on brain health. This other “silent pandemic” has indeed insidiously crept into people’s lives, with consequences that are difficult to estimate today. To contribute to and deepen COVID-19 research related to brain disorders and mental health issues, the Human Brain Project (HBP) and its research infrastructure EBRAINS are launching and funding a new Call for Expression of Interest (CEoI), inviting researchers to propose new study projects.

- COVID-19 research activities that are linked to and supplement HBP/EBRAINS and other activities at European or national level in this research field, e.g. funded by Horizon Europe, to create synergy and increase impact through including the EBRAINS Research Infrastructure.
- Longitudinal and cross-sectional analyses of patients suffering from neurological and/or psychiatric symptoms after infection with COVID-19, e.g. based on existing large cohorts
- Exploration of changes in brain structure and function in patients that have undergone COVID-19, e.g. targeting brain mechanisms underlying olfaction, memory, fatigue, depression
- Disease mechanisms and genotype-phenotype relationships as far as they concern the brain
- Short- and middle term effects of COVID-19 and related changes on mental health and brain health, e.g. related to age and demographic factors
- Development of mathematical brain models of patients and subjects affected by COVID-19
- Modelling and simulation of COVID-19 disease scenarios using EBRAINS
- Identification, modelling and simulation of drug candidates using EBRAINS
- Research on middle and long-term effects of COVID-19 vaccines on the brain and mental health
- Developing and testing strategies for prophylaxis, based on EBRAINS

Budget: EUR 450,000 Direct Costs. Maximum funding per proposal: EUR 225,000 (plus 25% Indirect Costs). Two proposals will be selected.

Deadline: **30/04/2021** (17:00 Brussels time)
